This study aims to assess the outcome of the Aikyashree Scheme whether the desired objective have been achieved. It will also take into factors which might have affected the desired outcome adversely like unavailability of teachers, deficiency in basic infrastructure and teaching materials etc. The social and educational impact will also be covered in the study.



**Impact assessment survey of Institutions Implementing the Aikyashree Scholarship Scheme and survey of infrastructure at Govt. and Govt aided Madrasahs.**

### TERMS OF REFERENCE

- 1. Back Ground.** The State Govt. Sponsored scheme Aikyashree was launched in Academic year 2019. The objective of Aikyashree is to enhance access and improve quality of education to the minority students. The scheme envisages enhancing the enrolment of minority students at all level improving quality of education imparted at students in term of results, drop out etc, deficiency in basic infrastructure of the institutions etc, which might have adversely affected the social & educational impact of Akiyashree scheme
- 2. Objective.** The objective of the impact assessment survey is to seek professional opinion on the effectiveness of the scheme in drawing minority students to institutions and in generating interest among students to pursue higher studies.
- 3. TERMS OF REFERENCE**

The terms of reference of the study are:-

- (a) To analyze the major output of the scheme since its inception vis-à-vis the desired outputs.
- (b) To analyze the impact of the scheme on minority students studying in minority institutions like Govt. and Govt. aided madrasahs.
- (c) To analyze/assess major outcome of the scheme vis-à-vis desired outcome with analysis of parameters such as Gross Enrolment Ratio, Drop-out rate, Gender gap, learning outcomes, quality of education, equity aspects, deficiency in basic infrastructure which might have adversely affected the social & educational impact of Akiyashree scheme.
- (d) To analyze the impact of the Scheme on quality of education due to intervention such as teachers' recruitment, teachers' training, Curriculum revision, Physical infrastructure, other activities like use of Science kit, Maths Kit, Promotion of Yoga, Project on enhancement of learning.
- (e) To justify/recommend about the continuation of the scheme or otherwise.
- (f) To suggest measures for improvement of implementation and monitoring mechanism for the scheme

### **4. METHODOLOGY**

- (1) A field sample survey of 20% Institutes from all Districts of the states to be chosen in consultation with WBMDFC will be conducted. During the visit the team will interact with officials at State & District levels and also visit schools. Atleast 10 District will be selected randomly for field visit. Also, in each selected district, the team will visit at least 6 schools including rural schools and schools in educationally Backward Blocks.
- (2) Review of the various data sources for educational indicators to assess the progress over the years.

## 5. TIME SCHEDULE

A draft appraisal report would be submitted within 1 month of the date of signing of agreement. The major findings of the draft report should be shared with the District Authority. Feedback from the Districts should be taken into account by the Consultant in the final report in a substantive manner and for the record. Districts will be required to provide written response within 15 days of receipt of draft report. The consultant will submit the final report within 2 months of the date of signing of agreement, after taking into account the comments of the WBMDFC on the draft report. Four hard copies along with soft copy of the Final Review Report shall be submitted to WBMDFC within a period of four months from the date of signing of agreement.

## 6. INPUTS TO BE PROVIDED BY WBMDFC

WBMDFC will facilitate interaction of agency/individuals/consultants with the Districts as well as their visits to the selected districts and sub-district level units. A representative of WBMDFC would accompany the team during the State visit. It will also provide copies of (i) Framework for Implementation of Aikyashree Scholarship Scheme (ii) Comprehensive report on implementation of Aikyashree at minority institutions.

## 7. DELIVERABLES

The Consultant shall submit a detailed report indicating the following:

- (i) Status of implementation of the scheme.
- (ii) Status of achievement of desired output and outcome under the scheme.
- (iii) Recommendations on further improvement of scheme with objective of meeting its targets.
- (iv) Recommendations on better use of available data managed through UDISE, NAS, PMS reports of monitoring institutions for scheme monitoring and control.
- (v) Recommendations on improvement of quality of education with special attention to Girls, other backward castes minority students factoring in the educational qualification of teachers and trainings provided to the teachers.
- (vi) Recommendations on improvement in infrastructure facilities in schools
- (vii) Recommendations on the systems at the field level for ensuring the efficient procurement of requisite/approved works/goods/services and the methodology to be used for the purpose. Also innovative efficient method may be suggested as against the existing practice.
